

## GENERAL CONDITIONS OF RESERVATION OF A MOBILE HOME - CAMPING LE VERCORS\*\*\*

1. Rental periods requested may not be less than one full week in the months of July and August. Each week starts on Saturday at 3 p.m. and ends the following Saturday at 10 a.m.
  2. The reservation becomes effective after our agreement and receive a deposit of 300€ / week or the total cost for a price < 300 € and 18 € booking fee for a winter stay.
  3. On receipt of your deposit, confirmation will be sent to you by e-mail.
  4. The option is kept open for no more than 8 days.
  5. It is advisable to take out the proposed cancellation insurance. It is the guarantee to be refunded the sums paid to the campsite in the event of cancellation or interruption of stay. Its cost is 3.5% of the cost of the stay except booking fee and tourist tax. The amount is payable in full at the time of booking. It adds to that of the deposit and concerns the persons registered for the stay. No refund will be made without subscription to this insurance. The conditions of this insurance are available upon request.
  6. Reservations are made in the hirer's name and may not under any circumstances be transferred or sub-let. The number of people stated in the contract may not be exceeded, except by agreement with the management.
  7. In the event of cancellation, deposits are not returnable and reservation fees are retained by the camp site.
  8. The charge for the whole rental period is payable on arrival together with tourist tax. No reductions will be made in the event of late arrival or early departure.
  9. In the absence of a message (by post, e-mail or fax) stating that the date of the stay has had to be postponed, the mobile home will be held to be free for rehire 24 hours after the date of arrival stated in the rental contract.
  10. A deposit of 200 € will be requested upon arrival of the tenant as a guarantee of the state of housing and equipment. The inventory will be taken on the day of arrival and day of departure of the tenant. In case of damage, the corresponding amounts will be deducted from the deposit. On arrival, a 72-hour period is up to you to report problems in the rental. Cleaning is the responsibility of the tenant unless the household option was chosen. The accommodation must be left in a perfectly clean when vacant.
  11. Renters must bring their own sheets and towels unless the cloth option was chosen.
  12. Dogs (just one and tattooed and vaccinated) are admitted to mobile homes (except some models) provided they are kept on a lead and do not relieve themselves inside the camp site. A vaccination certificate is obligatory and must be produced on arrival.
  13. Hirers are required to have civil liability insurance. The hirer certifies that he/she is insured.
  14. Hirers are requested to acquaint themselves with the internal regulations of the camp site on arrival and to abide by them throughout their stay.

## GENERAL CONDITIONS OF RESERVATION OF A PITCH : TENT, CARAVAN OR CAMPER VAN

1. Reservations can only be accepted for stays of at least 2 nights.
  2. The booking takes effect only after our agreement and upon receipt of a deposit of 50 € plus 8 € booking fee.
  3. Upon receipt of your deposit, the confirmation will be sent to you by e-mail.
  4. The option is kept open for a maximum of 8 days.
  5. Locations will be allocated in the order of confirmed reservations.
  6. In the absence of a message (by post, e-mail or fax) indicating that the date of the stay had to be postponed, the reserved accommodation will be considered free to be rehired 24 hours after the indicated arrival date. rent lease.
  7. Reservations are made in the name of the tenant and can't be transferred to other persons without our agreement.
  8. In case of cancellation, the deposit is not refundable and the booking fees are retained by the campsite.
  9. The reserved area will be available on the first day of the reservation period starting at 12 noon and the profession will end on the last day at 12 noon.
  10. Dogs (just one and tattooed and vaccinated) are admitted to the campsite provided they are kept on a leash and do not relieve themselves inside the campsite. A vaccination certificate is compulsory and must be produced on arrival.
  11. Visitors are admitted to the camp under the responsibility of the campers who receive them and are subject to a daily charge. The reception must be informed of their presence, and they must park their cars at the entrance.
  12. Caravans must be occupied by their owners: the rental is not allowed.
  13. Children are admitted to the site accompanied by their parents.
  14. The cost of removing a caravan from a snow-covered site shall be borne by the owner of the vehicle.
  16. The pool is not monitored. Swimmers should wear narrow swimming suits. Baggy shorts and luggage are prohibited.
  17. Guests are advised to read the rules and regulations of the campsite on arrival and to comply with them.
